AA members on the "outside" can contribute to their own sobriety and that of the inmate by becoming a Corresponding Contact. The Corresponding Contact communicates with the inmate by letter sharing their experience, strength and hope. This helps the inmate to become acquainted with AA on the outside and your letter becomes a meeting in print for the inmate. If you are a current active volunteer going into a Colorado Dept. of Corrections facility you may not participate in this service as per CDCC volunteer guidelines.

It is suggested that men work with men and women work with women.

Group participation with individual inmates is encouraged.

The Correspondence Chairperson will send you the name and address of the inmate along with guidelines we have found useful.

Esto ayuda el preso a familiarizarse con AA en el exterior y su carta se convierte en una reunión en la impresión para el preso.

Se sugiere que los hombres trabajan con hombres y mujeres trabajan con las mujeres.

Se fomenta la participación del grupo con los reclusos individuales.
